#### Program Overview

### Torian Easterling, MD, MPH



#### Senior Vice President for Population and Community Health Chief Strategic and Innovation Officer One Brooklyn Health

Dr. Torian Easterling is a family medicine and public health physician, serves as the Senior Vice President for Population and Community Health and Chief Strategic and Innovation Officer for One Brooklyn Health. OBH is a threemember hospital system, with an extensive network of primary and specialty care in Central Brooklyn, whose mission is to preserve and enhance delivery of care in Central Brooklyn. Prior to his role at One Brooklyn Health, Dr. Easterling served as the First Deputy Commissioner and Chief Equity Officer at the NYC Health Department. As the First Deputy Commissioner and inaugural Chief Equity Officer, Dr. Easterling worked to align the agency's external and internal equity initiatives. He led the City's equity response for the COVID-19 pandemic, including ensuring equitable distribution of vaccines to populations and communities hardest hit. He also led implementation of anti-racist public health practices including the agency's internal Race to Justice program and oversaw the Health Department's Take Care New York initiative which centers community collaboration to reimagine neighborhood health. Dr. Easterling spent more than 7 years in a senior leadership role at the Health Department, leading initiatives focused on reducing overall premature mortality and closing the racial gap for the top leading causes of preventable death. Prior to the Health Department, Dr. Easterling served as an Assistant Professor for the Department of Family Medicine at Rutgers New Jersey Medical School (NJMS) training medical students and implementing community health initiatives.

Dr. Easterling holds a Bachelor of Science from Morehouse College (Atlanta, GA), a Doctor of Medicine (MD) from Rutgers-New Jersey Medical School, and a Master of Public Health (MPH) from Icahn School of Medicine at Sinai in New York. He completed his residency in Family Medicine at Jamaica Hospital Medical Center in Queens, NY, and a General Preventive Medicine residency at Icahn School of Medicine at Sinai in New York.



### Mauvareen Beverley, MD, PLLC



#### Patient Engagement and Cultural Competence Specialist

Dr. Mauvareen Beverley is an executive-level physician with 20 years of experience advocating for improving patient engagement and cultural competence for all populations, and especially African American communities. Dr. Beverley is a member of The National Medical Association (NMA) and her article, Patient engagement and cultural sensitivity as a strategy to improve health equities: The solutions are simple as they are complex, was published in the NMA Journal in 2022. She is also a member of The National Association of Health Service Executives (NAHSE), American Medical Association (AMA). Dr. Beverley is a Fellow at the New York Academy of Medicine (NYAM) and her abstract, Health Disparities and Epidemics: Perception vs. Reality, was selected for presentation at NYAM 12th Annual History of Medicine.

In 2021, she received the Excellence in Medicine Award from the Bronx County Medical Society. Dr. Beverley received her bachelor's degree from Boston University and her Doctorate of Medicine from the University of Buffalo's Jacobs School of Medicine. Karen Roberts Turner, Esquire is a DC-based attorney with nearly 34 years of experience handling complex civil, commercial, and medical malpractice cases. During her 22 years in private practice, Ms. Turner developed a reputation as a highly skilled trial attorney and a formidable opponent. 
### Dinushika Mohottige, MD, MPH

Dr. Dinushika Mohottige is Assistant Professor in the Institute for Health Equity Research at the Icahn School of Medicine at Mount Sinai and the Barbara T. Murphy Division of Nephrology. She received a B.A. in Public Policy and a Health Policy Certificate from Duke University in 2006, where she was a Robertson Scholar. She then earned an MPH in Health Behavior/Health Education from the UNC Gillings School of Global Public Health and a medical degree from the University of North Carolina at Chapel Hill School of Medicine, followed by Internal Medicine/Chief Residency and Nephrology training at Duke University. She engages in patient and community-centered, inequityfocused research around the impact of socio-structural factors/racialized medicine on kidney health and kidney transplantation.





#### Associate Professor, Nephrology Pharmacist Howard University College of Pharmacy

Dr. Dhakrit Rungkitwattanakul (Jesse Rung) is an associate professor with the Department of Clinical and Administrative Pharmacy Sciences, Howard University College of Pharmacy in Washington, D.C. He received his Doctor of Pharmacy degree from University of Maryland School of Pharmacy and completed his residency training at Georgetown University Hospital in Washington, D.C. He maintains his clinical practice with the nephrology consult service at Howard University Hospital (HUH) where he trains students, residents, and fellows. At HUH, he established a nephrotoxin stewardship to improve the quality of care among medically underserved patients. Throughout his career in nephrology pharmacy, he has been focusing on the improvement of medication use among patients suffering from kidney failure and reducing gaps in health outcomes among African American patients. He is a board-certified pharmacotherapy specialist and a fellow of the national kidney foundation.



# Anthony C. Watkins, MD, FACS




#### Surgical Director, Kidney & Pancreas Transplant Program Tampa General Hospital Transplant Institute

Dr. Anthony C. Watkins is a board-certified surgeon specializing in abdominal transplant surgery and currently serves as the Surgical Director of the Kidney & Pancreas Transplant Program at the Tampa General Hospital Transplant Institute in Tampa, FL. He received his Bachelor of Arts from Fisk University in Nashville, TN, and his medical degree from the University of Tennessee College of Medicine. Dr. Watkins completed his general surgery residency at the University of Medicine and Dentistry, New Jersey Medical School in Newark, NJ, where he also spent two years conducting research on trauma hemorrhagic shock and multiple organ dysfunction syndrome. He completed his fellowship training in Multi-Organ Transplantation and Hepatobiliary Surgery at New York-Presbyterian Hospital/Columbia University.

Dr. Watkins has held several professional positions, including Assistant Professor of Surgery at NewYork-Presbyterian/Columbia University Medical Center, Assistant Professor of Surgery at NewYork-Presbyterian/Weill Cornell Medicine, where he also served as Program Director of the General Surgery Residency Program, and Clinical Associate Professor of Surgery at New York University Langone Health. His research is focused on addressing disparities in transplantation and enhancing diversity in the healthcare workforce. He is currently serving as the Chair of the Diversity, Equity, & Inclusion committee of the American Society of Transplant Surgeons and Chair of the Health Disparities & Equity Committee for the Society of Black Academic Surgeons. Currently, Dr. Watkins is the Co-Principal Investigator for an NIH U01 grant studying the impact of a program designed to mitigate disparities in access to transplantation for Black patients.





#### Gerald S. Berenson Endowed Chair in Preventative Cardiology Professor of Medicine, Tulane University School of Medicine

Dr. Keith C. Ferdinand is Professor of Medicine at the Tulane University School of Medicine and previously Professor of Clinical Pharmacology at Xavier University, New Orleans and Clinical Professor of Medicine at Emory University, Atlanta, Georgia.

Dr. Ferdinand received his medical degree from the Howard University College of Medicine in Washington, DC. He is board-certified in internal medicine and cardiovascular disease, certified in the subspecialty of nuclear cardiology, and a specialist in clinical hypertension. Dr. Ferdinand is a member of the Association of University Cardiologists, past Chair of the National Forum for Heart Disease and Stroke Prevention and prior Chief Science Officer and chair of the Association of Black Cardiologists (ABC). He has also served on the board of the American Society of Hypertension, the Southwest Lipid Association, and International Society of Hypertension in Blacks. He is presently on the board of the Partnership to Advance Cardiovascular Health, National Lipid Association, the Family Heart Foundation and the American Society for Preventive Cardiology. He was chair of the ABC Access to Care Initiative since 2016, a multi-organizational working group targeting disparities in the access to evidence-based medications and devices. He also serves the AHA National Hypertension Control Initiative (NHCI) Advisory Group, reflecting his unique perspective, experience, and expertise in hypertension. This group provides leadership and guidance to our national blood pressure initiative in the areas of clinical care and community health as an AHA cooperative agreement with the Office of Minority Health (OMH) and the Health Resources and Services Administration (HRSA). He serves advisor to the National Association of Community Health Centers Million Hearts initiative with the CDC. He has conducted numerous trials in hypertension lipids, cardiometabolic risk, and cardiovascular disease especially in racial/ethnic minorities, with over 300 peer-reviewed publications and lectures nationally and internationally.

In addition to his clinical work, he has participated in numerous clinical education activities in the community, locally and nationally, regarding eliminating disparities during the COVID-19 pandemic, as the president of Healthy Heart Community Prevention Project (HHCPP) 501(c)(3) nonprofit health organization in New Orleans. In 2004, Dr. Ferdinand received the Louis B. Russell, Jr. Memorial Award of the American Heart Association. Other awards include the Congressional Black Caucus Health Trust for journalism, the Charles Drew award for medical excellence from the National Minority Quality Foundation, the Wenger Award for Medical Leadership by WomenHeart and ABC Spirit of the Heart Distinguished Leadership Award and in the 2019 Xavier University Champion Award for health equity and AHA 2019 James B. Herrick Award for Outstanding Achievement in Clinical Cardiology. He received a 2021 and again in 2022 Health Care Heroes honor, for health care professionals in the New Orleans area. Dr. Ferdinand was honored as a 2023 Living Legend Honoree by the Center for African and African American Studies at Southern University at New Orleans. In 2024, he received the Anne C. Goldberg, MD, MNLA Foundation Service Award in recognition of excellence in clinical care and education on lipidology.



# Christina Pardo, MD, MPH, FACOG



#### Assistant Professor, Weill Cornell Medicine Medical Director, Women's Health Practice NewYork-Presbyterian - Ambulatory Care Network

Dr. Christina Pardo is an Assistant Professor of Obstetrics & Gynecology and Medical Director for Women's Health Practice. Prior to her current role she was founding Director for the Division of Health Equity at SUNY Downstate Health Sciences University Department of Obstetrics & Gynecology. She has worked both locally and globally to integrate equity into education, public health and clinical practice. She has expertise in working with immigrant communities and applying principles of cultural competency and humility having worked both globally and locally in immigrant communities.

Dr. Pardo has had extensive experience working globally in underserved communities and is currently the Director of Health for a development initiative in rural Haiti. She has partnered with Life of Hope, whose mission is to serve the immigrant community of Central Brooklyn. She has formed and overseen the Brooklyn Women's Equity Research Initiative, a consortium of four hospitals who provide obstetrics services to Central Brooklyn and established a research platform that has enabled several research initiatives. With other SUNY Downstate and community stakeholders, she co-leads a 2-year NYS Health Foundation grant entitled the Brooklyn Health Equity Index. In her current role, she oversees the management of care in a practice that services a predominant Medicaid population and work within the New York Presbyterian network to implement community and social services.

As an educator, Dr. Pardo has established a graduate medical education curriculum for Obstetrics and Gynecology residents focused on Women's Health Equity, integrating concepts on the social determinants of health and racism in medicine. She has collaborated with the New York City Department of Health on the implementation of programs geared to addressing Severe Maternal Morbidity. She served as an assistant professor, co-director, and director in the OBGYN Departments at Stony Brook, as well as SUNY Downstate. She is currently a member of American College of Obstetrics & Gynecology and has been recently inducted into the Alpha Omega Alpha Honor Medical Society.



### Ambereen Sleemi, MD, MPH, MSc, FACOG, FURPS



#### Co-Founder, Executive Director and Surgical Director International Medical Response Foundation

Dr. Ambereen Sleemi is a female pelvic medicine reconstructive surgeon and trained obstetric fistula surgeon. She is Co-founder, Executive Director and Surgical Director of International Medical Response and leads obstetric fistula training programs in Liberia, The Gambia, Pakistan and Haiti as well as medical relief projects in Ukraine, Vieques, PR and Destra, Haiti.

Dr. Sleemi served as an obstetric fistula surgeon for the Eritrean Women's Project in Mendefera, Eritrea since 2007 until 2018, and as a surgical team co-leader for Medicine in Action's medical trips to Kingston, Jamaica as well as on the medical board. She spent 8 years on the executive committee of the International Society for Obstetric Fistula Surgeons (ISOFS) and is still an active member. In January 2013, she developed the Haitian Women's Heath Collaborative in partnership with the Department of Ob/Gyn at the National Hospital in Port-au-Prince, Haiti and trained surgeons in FPMRS at St Boniface Hospital in southern Haiti.



### Hawthorne E. Smith, PhD



#### Director, Bellevue Program for Survivors of Torture President - National Consortium of Torture Treatment Programs

Dr. Hawthorne E. Smith is a licensed psychologist, and the Director of the Bellevue Program for Survivors of Torture. He is an Associate Clinical Professor at the NYU School of Medicine in the Department of Psychiatry, as well as the President of the National Consortium of Torture Treatment Programs. Dr. Smith received his doctorate in Counseling Psychology (with distinction) from Teachers College, Columbia University. Dr. Smith had previously earned a Bachelor of Science in Foreign Service from the Georgetown University School of Foreign Service, an advanced certificate in African Studies from Cheikh Anta Diop University in Dakar, Senegal, as well as a master's in international Affairs from the Columbia University School of International and Public Affairs.

Among his clinical duties, Dr. Smith has facilitated a support group for French-speaking African survivors of torture for the past 27 years. He also speaks extensively at professional conferences and seminars on providing clinical services for survivors of socio-political violence and enhancing crosscultural clinical skills among therapeutic service providers. Dr. Smith has been recognized for his work with such awards as: the Robin Hood Foundation's "Hero Award"; the "Frantz Fanon Award" from the Postgraduate Center for Mental Health; the "W.E.B. DuBois Award" from the International Youth Leadership Institute; the "Distinguished Alumni – Early Career Award" from Teachers College; the "Man of Distinction Award" from the National Association of Health Service Executives; the "Union Square Award for Community Advocacy" from the Fund for the City of New York; and a "Humanitarian Award" from the Cousul General of the Republic of Haiti .

Prior to coming to Bellevue, Dr. Smith was a youth counselor to "court involved youth" in Washington, DC during the height of the crack epidemic. He then coordinated care at a shelter for homeless families in San Francisco prior to, and in the aftermath of 1989 earthquake. Dr. Smith was also a co-founding member of Nah We Yone, Inc. (a non-profit organization working primarily with refugees from Sierra Leone, as well as other displaced Africans in New York), and helped to coordinate the International Youth Leadership Institute (IYLI), a leadership program for marginalized New York City teens. Currently, Dr. Smith provides forensic evaluations, human rights consultations, and mitigation services on capital cases for private legal firms and public entities such as the US Department of Defense and the US Office of the Federal Defender. Dr. Smith is also a professional musician (saxophonist and vocalist) with national and international experience.
