Geriatrician, AW Medical Care

Emilio Perez, MD, is an attending physician at AW Medical Care in the Bronx and is affiliated with Mount Sinai. He completed his residency in Internal Medicine at Saint Luke's-Roosevelt Hospital Center in 2008, and a fellowship in geriatric medicine also at St. Luke's in 2009. Dr. Perez is board-certified in Internal Medicine and in Internal Medicine Geriatric Medicine.

Dr. Perez is the former President of the Dominican Medical-Dental Society and currently serves as a board member. He is currently the Associate Director of Home Visits Program in the Department of Internal Medicine Division of Geriatrics at St. Lukes-Roosevelt Hospital Center.

Dr. Perez's professional interest and expertise lies in frailty, geriatric syndromes, dementia and cognitive decline, preventative care in the elderly, and palliative care. He has lectured on topics such as frailty, chronic complication of COVID-19, and geriatric dental care.



Ramon Rodriguez

Ramon J. Rodriguez is the President and Chief Executive Officer of Wyckoff Heights Medical Center, a 350-bed teaching hospital located on the border of Brooklyn and Queens, which has been a leader and top executive in healthcare, state government, and social services for over 30 years. A nationally recognized turnaround expert, he has set the hospital on a course of improved patient care and fiscal stability. Mr. Rodriguez joined Wyckoff in December 2011.

As a seasoned managed care executive, Mr. Rodriguez was co-founder and CEO of Socios Mayores En Salud Inc., a Medicare Advantage and health care provider company in the Commonwealth of Puerto Rico. He has also served as Executive Director of Sanus Health Plan of New York, Senior Vice President and General Manager of Health Net and President of Columbia Greene Medical Center, which consisted of two community hospitals and a nursing home.

In Mr. Rodriguez's state government and social services career, he has served as Chairman of the New York State Parole Board, Chief Counsel of the New York State Department of Correctional Services, and Executive Deputy Director for the Division for Youth and Executive Director of Union Settlement Association. He also was a Trustee of the New School for 27 years and a Board Member of the Primary Care Development Corporation.

He holds a Juris Doctor from DePaul University College of Law and Bachelor of Arts from City College of New York.



Esteve Montasell Jordana



Head Neuropsychology Service, ITA Salud Mental

Esteve Montasell Jordana is a graduate in psychology (2012), and a member of the College of Psychology of Catalonia. He holds a Master's Degree in Clinical Neuropsychology (2015) ISEP, a specialist degree in Psychotherapy by the EFPA (Europsy), a Master's Degree in Forensic Psychology (2020), and a Master's Degree in Treatment and Assessment of Eating Disorders (2021). Esteve is accredited as an expert in clinical neuropsychology by the General Council of Psychology of Spain (2018), and is the coordinator of the Neuropsychology Service of the ITA Group (Clariane Group) 2016), a spokesperson for the Innovation Committee - Clariane Spain (2021), and creator of the SAE (Spanish Acronyms for School Counseling Service, 2018). Esteve is currently a Doctoral candidate in Clinical and Health Psychology at the UAB in Barcelona. He's also an associated invited researcher with University of Lausanne (Switzerland), a teacher and tutor of internships and Master's final projects in different Masters of Neuropsychology programs in Spain and Ecuador.

Esteve began his care activity with a focus on brain damage in 2013. He worked in an organization located in a disadvantaged neighborhood in Mataró, Spain where he managed to start a day center without a budget. Afterwards, he changed his activity to behavioral disorders and the world of children and young people, developing from scratch the neuropsychology service at ITA in 2016, combining systemic and constructivist family therapists with neuropsychology. He advocates for the approach of neuropsychology towards psychotherapy and bringing neuroscience positions closer to daily clinical practice in mental health.

His research activity focuses on pragmatic aspects of day-to-day clinical practice; in order to obtain data to implement new neuropsychological instruments (D-Flex, The Monetary Choice Questionnaire or Contingency Naming Test), new normative data (CAT-Q, AQ, Stroop, UPPS-P) for adolescent populations such as Eating Disorders, Autism Spectrum Disorder, Personality variables and ADHD especially to help in the daily differential diagnosis. He collaborates with Dr. Joël Billieux (Lausanne University) and Dr. Joan Deus (UAB Barcelona). He is writing three articles in order to publish UPPS-P scale normative data for Adolescents and combine with other neuropsychological measures in clinical samples (ED, ASD, PTSD, BDP, FASD, ADHD amongst others) in order to research different cognitive profiles based on a symptom approach.

Esteve is currently involved in two innovation projects in ITA, such as ContigoCare® App (working with partner Eb2 solutions) for monitoring change in patients with substance use disorders and in Macthmind project (with partner Medea), designed to match the best therapist to the right patient.



Henry Chen, MD



President, SOMOS Community Care

Dr. Henry Chen has been in private practice for more than 27 years in New York City, where he manages the healthcare of patients in the Asian communities of Brooklyn and Manhattan. Dr. Chen graduated from Guangzhou Medical College in 1982, majoring in Medicine, and graduated from the Sun Yat Sen University of Medical Science with a master's degree in surgery in 1987.

Dr. Chen completed his three-year intensive residency training program in Internal Medicine at the New York Hospital of Queens (Cornell Medical School) in 1996. He is an internist, geriatrician, and licensed physician acupuncturist. He established Jennan Comprehensive Medical P.C., opening multiple locations since 1996 and partnered with other PCPs to form Excelsior Integrated Management Corp, an exclusive MSO for Excelsior Integrated Medical Group PLLC, a multi-specialty medical group practice in 2013. Dr. Chen has been serving as CEO since its inception, with over 21 primary care sites and 22 different specialties across Brooklyn, Manhattan, and Queens. All Excelsior's PCP and primary care sites with over one year operation have been recognized by the National Committee for Quality Assurance (NCQA) for level III Patient-Center Medical Home (PCMH), diabetes recognition by NCQA and received grants from the Department of Health, State of New York. This model was selected by the Medical Society of the State of New York (MSSNY) as one of the very few models that MSSNY recommended to its entire membership in the State of New York for survival of independent practice.

Dr. Chen has been actively engaged with physician organizations and the community in many ways besides his busy practice. He is the founding member and past President of the Association of Chinese American Physicians, Founder and CEO of the Eastern Chinese American Physician IPA, Founder and CEO of the Chinese Community Accountable Care Organization, with 6 consecutive years receiving share savings from CMS. Lastly, he is the Founding President of SOMOS Community Care, a network of over 2500 community based providers, serving the most vulnerable immigrant communities such as Latino and Chinese, addressing the healthcare disparities among the fast growing minority groups.

Due to his dedication and outstanding services to patients and the community, Dr. Chen was awarded the Certificate of Achievement by New York City Council in 2016, Community Care Award by the Chinese Chamber of Commerce of New York in 2018, Visionary Leadership Award by the Visiting Nurse Services of New York in 2019, Lifetime Achievement Award by ACAP in 2019, Spirit of Asian American Award by the Asian American Federation in 2019, The 100 Most Powerful Asian in New York by the State and City of New York in 2020, 2021 and 2022, the 100 Healthcare in New York State in 2021 and 2022 for his services to the Asian community, and for his leadership and direct participation in the fight of COVID-19 pandemic.

Dr. Chen's dedicated services to New Yorkers during the COVID-19 pandemic, from the beginning of testing to current vaccination of all New Yorkers, has been recognized by New York City Mayor De Blasio and New York State Governors Andrew Cuomo and Kathy Hochul at both governmental conferences and in the media numerous times. Dr. Chen received a Certificate of Recognition from New York State Governor Kathy Hochul in June 2022, and President's Lifetime Achievement Award from the President of United States Mr. Joseph R. Biden, Jr. in 2022, as well as a Certificate of Special Congressional Recognition by US Congresswoman Grace Meng in November 2022. Dr. Chen also received the Public Champion Award by Chinese American Nurses Association May 2023 and Tribute to Excellence in Healthcare by United Hospital Fund of New York State in May of 2023.



Marie-Ignace G. Morel, MD, FACOG



Director, Regional Perinatal Intensive Care Center Perinatal Specialists of the Palm Beaches

Dr. Marie-Ignace G. Morel, MD, FACOG, is an esteemed Perinatologist and the former Director of the Regional Perinatal Intensive Care Center in West Palm Beach, Florida. At present, she is a senior Maternal Fetal Medicine Specialist at Perinatal and Gynecologic Specialists of the Palm Beaches, serving in the West Palm Beach, Wellington, Boca, Port St. Lucie, and Boynton Beach offices.

Dr. Riaño was born in Bogota, Colombia and obtained his medical degree from the Pontificia Universidad Javeriana, Bogotá, Colombia. He moved to the United States and completed his residency in obstetrics and gynecology at Flushing Hospital Medical Center, where he has worked, and now serves as Associated Program Director for the Ob/Gyn residency, and adjunct clinical assistant professor for the New York Institute of Technology, College of Osteopathic Medicine.

Dr. Riaño has a special interest in minimally invasive surgery and robotic surgery. He is certified by the American Board of Obstetrics and Gynecology and holds an active membership in the American College of Obstetricians and Gynecologists. Joshua J. Joseph, MD, MPH, FAHA



Associate Professor of Internal Medicine, The Ohio State University Wexner Medical Center

Joshua J. Joseph, MD, MPH, FAHA is an Associate Professor of Internal Medicine with Tenure and the Endowed Professor for Research in Internal Medicine in the Division of Endocrinology, Diabetes and Metabolism at The Ohio State University Wexner Medical Center (OSUWMC). He is Co-Chair of the OSUWMC Healthy Communities Obesity and Nutrition Steering Committee and Medical Director of The OSUWMC Healthy Community Center.

Dr. Joseph's National Institutes of Health, American Heart Association, Agency of Healthcare Research and Quality, Robert Wood Johnson Foundation, and United States Department of Defense funded research focuses on advancing prevention and treatment of diabetes and cardiovascular disease through a health equity lens with 4 pillars: 1) Examining the role of stress hormones in Cardiometabolic Disease; 2) Health System to Community Innovations; 3) Community-Based Participatory Research; and 4) Quality Improvement Science.

Clinically, Dr. Joseph treats patients with diabetes and cardiovascular disease at a community-based clinic. Nationally, he is chair of the Endocrine Society Clinical Affairs Core Committee, Chair-Elect of the American Heart Association Council on Lifestyle and Cardiometabolic Health Diabetes Committee, and President-Elect of the Central Ohio American Heart Association Board. He has been recognized for his science, community engagement, and clinical impact with several awards including election to Alpha Omega Alpha, National Minority Quality Forum 40 under 40, and the American Society for Clinical Investigation.



Shawna D. Nesbitt, MD, MS



Professor, Department of Internal Medicine, UT Southwestern Medical Center, Medical Director, Parkland Health & Hospital System's Hypertension Clinic, Vice President and Chief Diversity, Equity, and Inclusion Officer, UT Southwestern

Shawna D. Nesbitt, MD, MS is a Professor in the Department of Internal Medicine at the University of Texas at Southwestern Medical Center in Dallas, Texas, where she is the Medical Director of the Hypertension Clinic at Parkland Hospital. Dr. Nesbitt earned her medical degree at Hahnemann University School of Medicine in Philadelphia, Pennsylvania.

After an internship and residency in internal medicine at Allegheny General Hospital in Pittsburgh, Pennsylvania, she underwent fellowship training in hypertension in the Department of Internal Medicine, University of Michigan Medical Center in Ann Arbor, Michigan. Additionally, Dr. Nesbitt earned a Master of Science in clinical research design and statistical analysis from the University of Michigan, School of Public Health. She is board-certified in internal medicine, and she is a Fellow of the American Heart Association Council for High Blood Pressure Research and a Fellow of the American Society of Hypertension. She is a certified Hypertension Specialist. In addition, she is an alumnus of the Executive Leadership in Academic Medicine program.

She is a former President of International Society of Hypertension in Blacks (ISHIB) and remains a member of the Board of Trustees. She is also a current Board member of the Southwest Affiliate and the National Scientific Advisory Committee of the American Heart Association, and the American Society for Hypertension. She served as a member of the Clinical Trials Review Grant Study Section for NIH/NHLBI. She is currently a member of the Observational Study Review Board for The Jackson Heart Study sponsored by NIH, NHLBI. Her research interest is in clinical trials in hypertension and cardiovascular prevention. She has served as national leader in hypertension clinical trials with a special focus on prehypertension, hypertension in African Americans, and healthcare disparities. She is currently a site principal investigator for the ASPREE clinical trial. Dr. Nesbitt is an active clinician as well as Medical Director of the Hypertension Clinic at Parkland Hospital.

Dr. Nesbitt received the Women Who STEAM (Science, Technology, Engineering, Arts, and Math) Award in 2019 from the Dallas Chapter of The Links, Incorporated. She was also named a 2016, 2017, and 2018 D-Magazine Best Doctor.

Dr. Nesbitt has served as Associate Dean of Student Affairs in the Office of Student Diversity and Inclusion of the University of Texas Southwestern. She led the team at the Medical School, Graduate School, and School of Health Professions who focus on efforts to recruit students from diverse backgrounds, and to create educational programming that supports an inclusive environment preparing students for careers in science and medicine. She is active in guiding education for the medical school in cultural sensitivity and approaching diverse patients focused on creating equity in science and medicine. As of October 1, 2022, she began a new role as the Inaugural Vice President and Chief Diversity, Equity and Inclusion Officer at UT Southwestern.

At the request of the Cardinal of the Archdiocese of New York, Dr. Tallaj moved to the United States to provide medical care to New York's Hispanic immigrant communities and established his first internal medicine practice in Washington Heights in 1997.

In 2015, he founded SOMOS Community Care ("We Are" in Spanish), a culturally competent physician-led network of 2,500 healthcare providers serving over 1 million Medicaid and Medicare beneficiaries in New York City's immigrant communities. SOMOS was one of 25 Performing Provider Systems (PPS) in New York's DSRIP program. Dr. Tallaj has championed the pay-for-performance model in New York State to improve health outcomes by enhancing preventive and chronic care management. Since 2018, SOMOS has saved New York taxpayers over \$336 million by reducing ER and hospital admissions by more than 35%.

Since the start of the first wave of the pandemic, Dr. Tallaj has been active in calling global attention to the disproportionate impact of COVID-19 in communities escalating illness and mortality rates in New York's inner cities.

During its darkest days, Dr. Tallaj was responsible for operating over 125 trilingual COVID-19 sites and provided free testing to over 1.5 million people, along with free health education, and call centers in 5 different languages, when technology and access were nearly impossible. Through his humanitarian efforts, SOMOS was able to serve over 2 million fresh-to-go meals to some of the poorest and food-insecure neighbors, while still providing free accessible healthcare to immigrant communities during a period of extreme medical crisis.

Dr. Tallaj's organization proved to be an even a greater community resource in the depths of the COVID-19 crisis, becoming the first primary care group in the State of New York to administer millions of COVID-19 vaccines to vulnerable New Yorkers in SOMOS's medical offices, along with launching hundreds of pop-up sites in local churches, public housing, and landmark mega-sites like Yankee Stadium.

On February 17th, 2022, Dr. Ramon Tallaj was appointed as the co-chairman of New York City's COVID-19 Recovery Roundtable and Health Equity Task Force, directed by Mayor Eric Adams. He advises on all the comprehensive policies focusing on healthcare access and equity to help rebuild New York City's post-pandemic economy and long-term growth for all New Yorkers.

Shariff de los Santos graduated from Universidad Iberoamericana (UNIBE) as a medical doctor. He has vast experience in primary care services and has played numerous roles in the healthcare administration of the State of New York.

In New York, he successfully managed the Cardiovascular Project in one of the largest PPS of the Medicaid redesign program (DSRIP). In 2016 he was promoted to Director of the Clinical Projects of the PPS and in 2017 he was nominated as Vice-President in the organization, where he directly oversaw the performance of more than 2,500 Primary Care Physicians in NYC.

Since 2020, Shariff has been in charge of the operations of NYC Medical of Queens.
