



What: Healthfirst has reinstated the Medicaid Management Information System (MMIS) enrollment requirement.

Why: At the direction of the New York State Department of Health (NYSDOH), failure to enroll will result in termination from any Healthfirst network that serves MMC, CHPlus, or PWP members. Click here for more information from NYSDOH.

In addition, new requests received to enroll qualifying providers into the Healthfirst network will be rejected if the provider does not have an MMIS number or is not reflected on the eMedNY Medicaid Pending Provider Listing. Please ensure you are enrolled in NYS Medicaid.

Important: Enrollment as a Medicaid provider does not require you to accept Medicaid fee-for-service (FFS) patients. Participating providers with a specialty referenced in the Categories of Service (COS) list below who do not currently have an MMIS number are required to enroll in Medicaid immediately to avoid disruption in participation status with Healthfirst.

Follow these steps to enroll in Medicaid

Note: you will need to complete paperwork and submit it to New York State Medicaid.

- 1. Please click **here** and navigate to your provider type to print and review the Instructions and the Enrollment form.
- 2. On the website, you will also find a Provider Enrollment Guide, a How Do I Do It? resource guide, FAQs, and all the necessary forms related to enrollment in NYS Medicaid.
- 3. Additionally, you may contact CSRA's eMedNY Call Center at **1-800-343-9000** if you have questions regarding the enrollment process.

If you're a former Medicaid provider with a lapsed enrollment (no longer actively enrolled), you may be able to keep your original Provider Identification Number (PID), also known as MMIS ID, by indicating 'reinstatement' on the application. A practitioner may enroll either as a non-billing, Ordering/Prescribing/Referring/Attending (OPRA) provider or as a Medicaid billing provider. Business, Group Practice, and Institutional provider types will be offered the option to enroll in Medicaid as a billing or non-billing (Managed Care Only) provider.
